## **Official Rules**

## World of Warcraft: Legion Beta Giveaway Contest

1. Eligibility. BLIZZARD ENTERTAINMENT SAS, A FRENCH COMPANY (referred to herein as "SPONSOR") IS THE SPONSOR OF THIS CONTEST.
