LEGAL TERMS FOR "VISIONS OF MADRID" CONTEST

MADRID DESTINO CULTURA TURISMO Y NEGOCIO S.A. (further on, "MADRID DESTINO") with its registered office in Madrid, C/ Montalbán 1, 7th floor, Postal Code 28014 and CIF number A-84073105, is a municipal company belonging completely to Madrid City Council. Its social objective, among other activities, is the management of municipal politics of touristic information and promotion of the city of Madrid and projection and diffusion of its image nationally and worldwide.

MADRID DESTINO, intending to promote the city of Madrid's tourism, as well as the the Official of Madrid's dynamization on Page the citv of Facebook (www.facebook.com/MadridCiudad) and Instagram (http://instagram.com/madridciudad), and loyalty of its fan community, has decided to hold the present contest, under the title of "Visions of Madrid", in which it will be allowed the participation of any person who fulfills the established conditions in these Terms, available for consultation at the same Facebook profile.

1. OBJECTIVE

The objective of these present Terms is to define the functioning of the contest by merits "VISIONS OF MADRID", in which a prize of a trip for two people to Madrid will be given to the photography that best represents the city of Madrid's values, that will be chosen by a jury among the 20 most voted pictures published on Madrid's Facebook fan page.

2. PARTICIPATION REQUIREMENTS AND TERRITORIAL SCOPE

To be able to participate in this present contest, these requirements must be fulfilled:

- To be a person at least 18 years old, or of legal age in his/her country of origin.
- To be registered as a user on Facebook <u>www.facebook.com</u> and like the city of Madrid's official Facebook profile (<u>www.facebook.com/MadridCiudad</u>), as well as being registered as a user on Instagram.

The directive staff and its employees, as well as collaborators, contractors and/or personnel subcontracted directly or indirectly of MADRID DESTINO will not be allowed to participate in the contest "VISIONS OF MADRID". If this situation is to happen, and the prize has already been claimed, they will be forced to pay the monetary amount of the prize as well as any monetary compensation that might need to cover any possible damages.

The territorial scope of this contest is for residents living in Brazil, Italy, Denmark, Germany, Mexico, USA, United Kingdom and France.

3. DURATION

Participation in this contest will begin December 19th 2013 at 00:01 hours and will finish February 14th 2014 at 23:59 hours (Madrid local time, GMT +1).

The winner of the contest will be announced February 21st, 2014.

4. WAY TO PARTICIPATE IN THE CONTEST

The participation in the contest is free and will have no cost or additional charge.

The contest will take place through Madrid's Facebook fan page and its Instagram profile.

To participate in the contest, the users must follow this procedure:

- Click "like" on the official Facebook page of city of Madrid (<u>www.facebook.com/MadridCiudad</u>) (in the possible case of not being a fan).
- Then, the user must upload from his/her personal Instagram profile one image of Madrid with the hashtag #VisionsofMadrid. The competitor must be the author of the image or have its rights.
- The shared picture for the contest can be an image of Madrid, a drawing of the city or any other image that reflects Madrid's essence.
 - The contender can invite his/her friends to vote for his/her submission sharing the application that will be activated for the contest's management on Facebook "Visions of Madrid" https://apps.facebook.com/vision of madrid
- The images will be subject to control and moderate, so that the submissions that don't meet the requirements will be eliminated and discarded immediately from the contest. Those who are approved by MADRID DESTINO, will be displayed in the image gallery of the Facebook application "Visions of Madrid "<u>https://apps.facebook.com/vision_of_madrid</u> and will be able to be voted and shared by all the users that have clicked "like" on Madrid's official Facebook page.

The management and storage of the submitted images will be done according to the established conditions of Facebook and Instagram. MADRID DESTINO has no association with Facebook or Instagram and is not responsible for such conditions.

4.1. Participant's image restrictions

In order to approve the image for the contest, and therefore the possible winner, it must fulfill the following requirements:

- The image can't undermine in any way people's dignity, the right to honor, personal and familiar privacy and their own image go against young or infant people's rights or any other fundamental right recognized constitutionally, as well as any way of racial or sexual discrimination that condones violence or criminal activity.
- The image must not infringe or violate any right of a third person, including but not limited the copyrights, intellectual and industrial property rights, contract or license agreements, publicity, privacy, etc.
- The image must not include or be accompanied by any content that could be considered offensive for MADRID DESTINO and/or could harm the name, reputation, fame, image or good will of MADRID DESTINO and/or any other society bound to it. If this situation is to happen, MADRID DESTINO reserves the right to delete de image, excluding automatically its participation from the contest.
- The image must not, including but not limited, mention and/or refer to other brands, logotypes, emblems or similar, images, commercial names, domains or any other symbol, denomination intellectual and industrial property right of any other public or private entity and/or any other third party (natural or legal person).
- By publishing an image and participating in such contest, the participant gives MADRID DESTINO the right to use and publicly communicate of such image in the city of Madrid's official Facebook profile, as well as other communication media managed by MADRID DESTINO, in order to promote the participation in the contest

Those participants who do not follow all of these requirements will not be able to participate in the contest.

Furthermore, images that don't follow the theme of the contest or that go against moral standards and public order, as well as the jury's good judgment, will be automatically excluded.

5. WINNER'S ELECTION, PRIZE AND ANNOUNCEMENT

5.1. Winner's election

The winning image will be chosen among the 20 most voted images from the application "Visions of Madrid" <u>https://apps.facebook.com/vision_of_madrid</u>, by a jury composed of MADRID DESTINO employees, that believe that better represents the city of Madrid's spirit and will become the winner of the contest. In addition, three (3) alternatives will be selected, in the event of the winner not being able to or not wanting to accept the prize

When choosing the winning image among the 20 most voted, and the 3 alternatives, the contest Jury will value criteria such as image quality, artistic beauty, creativity, originality and the best representation of Madrid's values.

5.2. <u>Prize</u>

The winner will receive the prize of one (1) trip to Madrid for two (2) people consisting of:

- Two round-trip airplane tickets from the winner's city of residence to the city of Madrid.
- 2 night stay for two people in a 3 or 4 star hotel in regimen of lodging and breakfast.
- A cultural activity pack for two people: Madrid Card for 24 hours, a Madrid City Tour route, tour of the Bernabeu Stadium.

The prize can be used between April 1st 2014 and September 30st 2014, subject to availability of flights and accommodation.

The prize is limited to the above, and anything additional is excluded and will be under the winner's responsibility.

The prize cannot be exchanged, altered or paid in cash, and is not transferable to any third party.

The prizes listed in this contest are subject to the corresponding tax legislation and MADRID DESTINO will execute any withholding and deposits that may apply. The winner is responsible for any remaining tax obligations.

5.1. Winner's announcement

Once the contest is over, February 21st 2014, MADRID DESTINO will announce the contest's winner through the application that will be on the city of Madrid's official Facebook **profile "Visions of Madrid"** <u>https://apps.facebook.com/vision_of_madrid</u> and MADRID's official Instagram account (http://instagram.com/madridciudad).

Consequently, the winner must write a private message through Facebook to the city of Madrid's official profile (<u>www.facebook.com/MadridCiudad</u>) providing his/her e-mail address,

that has to coincide with the winner's e-mail on Instagram. Once the winner's e-mail is received, and verified as the e-mail linked to the winner's Instagram, MADRID DESTINO will get in contact with him/her through e-mail, requesting the necessary information to issue the prize and inform him/her of its terms and conditions.

If there is no response from the winner in 48 hours from its notification through Instagram, he/she will no longer be awarded, the prize being passed on to the next alternative selected image, and so on.

6. INTELLECTUAL PROPERTY

All those who participate confirm that the images that are submitted are free of liens or charge that infringe third party's rights. In any case, the contestants will hold harmless MADRID DESTINO from any claim, complaint or lawsuit from third parties related to the possible rights that could have to do with the images.

MADRID DESTINO reserves the right to demand from the contest participants to confirm the ownership of the images submitted.

The contestants just by publishing an image authorize the public communication of their images in MADRID DESTINO's Internet portal and social media profile, as well as any other media that is considered appropriate to advertise the contest, from the beginning on the contest until the winner is announced.

The winning contestant will grant MADRID DESTINO the image's reproduction, communication and transformation rights during the maximum duration of these rights and with no geographical limits.

8. PERSONAL DATA PROTECTION

MADRID DESTINO informs the participants of the contest that the personal information will be incorporated to a file with the only and exclusive purpose of managing their participation in the contest and communicating with the winner in order to give him/her the prize.

By participating in this contest, contestants authorize the handling of their information according with these clauses.
