

## Skiset competition rules

### Article 1: Organiser

CELS, Nanterre RCS no. 877 610 923, with registered office at 424 Bureaux de la Colline, 92213 Saint-Cloud Cedex, France, is holding a competition with no purchase necessary from 4:00pm on 18 February 2022 until 4:00pm on 28 February 2022.

The competition is called *Skiset vous relooke* (Skiset Style Refresh). To visit the competition website, go to <https://shakr.cc/4cq0>

### Article 2: Terms and conditions of entry

2.1 The Competition is open to all residents of metropolitan France (including Corsica) aged 18 or over, regardless of whether they have made a purchase from

CELS, and who wish to enter online free of charge at <https://shakr.cc/4cq0>. The Company reserves the right to carry out any necessary checks to confirm an entrant's identity, postal address and/or email address.

2.2 The Competition is not open to employees of the Company and its Partners, including their family members and partners (i.e. through marriage, civil partnership/PACS, or other recognised or unrecognised conjugal relationship).

2.3 Entrants who do not provide proof of their contact details, or who provide incomplete, inaccurate or false information, or who refuse to allow their personal details strictly necessary to administer the Competition to be collected, recorded and used will be disqualified.

2.4 By entering the Competition, entrants unreservedly accept these rules in their entirety. Any breach of these rules shall result in automatic cancellation of the entry and any prize award.

2.5 Prizes may only be won by and awarded to residents of the following countries: France, United Kingdom, Germany, Switzerland, Austria, Spain, Belgium, Luxembourg, Andorra, Ireland, Portugal, Netherlands.

### Article 3: How to enter

To enter the Competition, entrants must:

1. Have a Facebook account and visit the competition page at <https://shakr.cc/4cq0>
2. Click on "Enter" and allow Facebook access to their data.
3. Complete the entry form, having read and agreed to the competition rules:

- Players may only enter the competition once per day. Winning entrants will be ineligible to make any further

entries.

- Players may go back into the application to invite their friends.
- The competition will run from 4:00pm on 18 February 2022 until 4:00pm on 28 February 2022.
- Winners are selected as follows: Each prize is made available to win on a set date and time slot, during which the first player to visit the competition page at <https://shakr.cc/4cq0> will win the prize.

### Article 4: Selecting the winners

One prize will be awarded to each winner (same name and address).

Winners will be named after it is confirmed that they are eligible for the prize. Winning entrants will be notified by the

Organiser by email. Entrants who do not come forward within one month of receiving the email will be deemed to have forfeited their prize, which will remain the property of the Organiser.

The Organiser accepts no responsibility for prizes sent to an inaccurate address due to the winner's negligence. Where prizes cannot be delivered to their recipient for any reason beyond the Organiser's

control (e.g. the winner has relocated without updating their address, etc.), the prizes shall remain the property of the Organiser.

Prizes may not be exchanged for another item or redeemed for their cash value, and are not eligible for a full or partial refund. Entrants are hereby made aware that the sale or exchange of prizes is strictly prohibited.

The value indicated for the prize(s) is equal to the current or estimated retail price including VAT on the date these rules were set. Values are indicative only and are subject to change. The Organiser accepts no responsibility for any incidents or accidents that occur as a result of using the prizes. All product or brand names mentioned are the registered trademarks of their respective owners.

#### Article 7: Disclaimer

By entering the *Skiset vous relooke* competition, entrants acknowledge and accept the limitations of the internet, in particular technical performance, connection times for viewing, requesting or sending information, the risk of service interruption and, more generally, the inherent risks of using and exchanging information over the internet, the absence of protection for some items of data against misuse or piracy, and the risk of infection from viruses that may be present on the network. As a result, the Organiser accepts no liability whatsoever in instances including, but not limited to:

2. network faults that impede or prevent the operation of the Competition;

7. consequences arising from viruses, computer bugs, technical defects or faults;
8. damage caused to an Entrant's computer or device;

The Organiser reserves the right to cancel, postpone, suspend or extend the Competition or amend some or all of the arrangements in, and in accordance with, these competition rules. The Organiser accepts no liability if, as a result of an event beyond its control, it is required to invoke this right.

The Organiser reserves the right to permanently disqualify individuals from all competitions, where their fraudulent actions disrupt the progress of the Competition. Furthermore, the endorsement of fictitious identities shall result in immediate disqualification. Equally, any attempt to use the competition outside of the unmodified interface provided on the website shall be considered attempted fraud. Furthermore, attempts to reverse-engineer the competition, use personal script, or employ any other method to circumvent the competition as provided under these rules shall be considered attempted fraud and result in immediate disqualification, with no right of recourse.

#### Article 8: Submission of competition rules

The rules are available free of charge on request from the Competition Organiser at 424 Bureaux de la Colline, 92213 Saint-Cloud Cedex, France. The cost of postage incurred to make a written request for a copy of the rules shall be refunded on request, based on the standard postal tariff.

#### Article 9: Personal data

To enter the Competition, players must provide items of personal information (e.g. name, address, etc.). This information is recorded and stored on a computer file and is necessary to account for their entry, select winners, and award and deliver prizes. This information is intended for the use of the Organiser, and may be shared with technical service partners and postal/carrier services engaged to deliver prizes.
