



## TERMS ADDRESSED TO "BARÇA FANS" NEWSLETTER SUBSCRIPTION "Draw 2 VIP tickets for the match Barça Lassa vs. Khimki Moscú" (-2018/2019 sport season-)

### CONDITION 1. SCOPE.

FUTBOL CLUB BARCELONA domiciled in Calle Arístides Maillol, s / n, 08028, Barcelona, and CIF number G-08.266.298 (hereinafter referred to as FC BARCELONA or the CLUB) shall promote an activity called "Draw 2 VIP tickets for the match Barça Lassa vs. Khimki Moscú" (hereinafter referred to as the "activity") aimed solely and exclusively to those subscribing to the "Barça Fans" newsletter, participating under the terms and conditions contained herein.

How to take part in the activity and how it works shall be communicated and promoted, among FC BARCELONA's other means of communication, on its official website ([www.fcbarcelona.com](http://www.fcbarcelona.com)) and social media of FC BARCELONA.

From the drawn to be held, one (1) person shall be named the winner out of who take part in the activity. The winner will receive the prize indicated in Condition 6.

For the above purposes, in the case of participants under legal age, their participation in each and every one of the corresponding phases described in these rules (acceptance of the Rules, requirements for participation, mechanics of the activity, acceptance of the prize, etc.) must always and in all cases be supervised by the person who holds his rights to representation and legal guardianship (parental authority, guardian, etc.). Therefore, in accordance with the above, FC BARCELONA understands that the consents and authorisations that correspond and are mandatory (acceptance of Rules, requirements for participation, mechanics of the activity, acceptance of the prize, image rights, collection and processing of data of a personal nature, litigation, etc.) shall be deemed to have been carried out for all purposes and without reservations by the persons holding their representation, protection and legal guardianship, on their behalf, and FC BARCELONA shall be exempt from any liability in this regard.

### CONDITION 3. AUTHORISATION OF USE OF PERSONAL DATA.

a) DATA CONTROLLER: Your data will be processed by FC BARCELONA, located in at Carrer Arístides Maillol s/n, 08028, Barcelona and with Spanish Tax Identification Number (NIF) G-08266298.

b) PURPOSES: The data shall be processed for the purpose to send you the Newsletter of the Barça Fans programme, which shall always be personalised and adapted to your interests.

We also inform that your data will also be treated in order to manage your participation, as well as to proceed to deliver and publish your name in the event that be the winner.

Likewise, and always provided that you have expressed your consent by checking the respective boxes for the said purposes provided in the form, we may process your data to:

- Send you additional information related to FC BARCELONA, such as opinion polls, invitations to events, or the CLUB's own products such as discounts or promotions for match tickets, merchandising, digital products, etc.
- Send you information, discounts or promotions from third parties with which FC BARCELONA might maintain a commercial or collaborative relationship, such as the FC BARCELONA Foundation, or sponsors or partners of the CLUB, who may carry out actions specifically aimed at Barça Fans.

c) **COMMUNICATION OF DATA:** Your data shall not be transferred, sold, rented or made available in any other way to any third party, except to those which supply services to FC BARCELONA, which perform certain activities for the CLUB (such as sending the newsletter), but that in no case shall process the data for their own purposes. Some of these suppliers may be located outside of the European Union, as indicated below.

If you wish to receive information from third parties, such as the FC BARCELONA Foundation or its partners or sponsors, this information will always be sent by FC BARCELONA, and we shall not provide them with any data, unless you have given us your express consent to do so.

d) **AUTOMATED DECISIONS AND CREATION OF PROFILES:** For some services, we may process your personal data using automated methods. This means that certain decisions are made automatically without human intervention. For example, we may segment you depending on whether you have any interest in certain sports sections of FC BARCELONA, or use our services, such as free Wi-Fi on our premises.

We may also create a profile by analysing your behaviour on the web, showing you products that may be of interest to you, based on the preferences you have shown through your browsing, or information obtained through cookies.

In addition, if you have agreed to receive commercial communications, these may be adapted and customized according to the interests of the users, either based on the products and services requested, or based on the data that we can deduct or obtain from your browsing, interest in certain contents, reaction to our communications, among others.

This personalization is conducted in a partially automated manner, in the sense that the CLUB determines the parameters of the personalization, but it is the technological platform that generates the user's profile. We do not send general communications that are not segmented by the previous procedure, since we consider it to be in the interest of both the CLUB and the users of the Barça Fans program for the information that is sent or received to be relevant, and because not segmenting would not alter the number of communications received by the Barça Fans program, but only the content of the same. In this regard, if any user of the Barça Fans program does not wish to be segmented, we ask them to refrain from subscribing to the Barça Fans program's communications.

e) **INTERNATIONAL TRANSFERS:** FC BARCELONA, as an international organisation, has international suppliers that may provide their services from outside the EU, so it is possible for users' data to be processed outside the European Union or the European Economic Area (for example, the supplier of newsletter delivery, data storage, management of requests for information or member services, etc.).

In any case, the CLUB will ensure that this data processing is always protected with the appropriate guarantees, which may include:

- Standard EU approved clauses: These are contracts approved by the European regulator, and which provide sufficient guarantees to ensure that the processing complies with the requirements of the European General Data Protection Regulation.
- Third party certifications: For example, Privacy Shield, the framework agreement between the EU and the United States that establishes a standardized framework for data processing according to the requirements of the European General Data Protection Regulation.

f) **DURATION OF THE PROCESSING:** All the data that you provide to subscribed our newsletter, we shall process your data until the CLUB considers that, by any means available according to the technology available at any time, you are no longer interested in its products. In any case, you may unsubscribe from the newsletter at any time.

Also all the data that you provide us during the participation in the contest will be process until the end of the contest.

After the term indicated, FC BARCELONA shall withhold your duly anonym zed data for statistical purposes or market analysis, whenever possible, or duly blocked to comply with any legal obligation of the CLUB.

g) **EXERCISE OF YOUR RIGHTS:** At any time you may revoke your consent to any of the uses of data indicated above.

## CONDITION 4. PARTICIPATION REQUIREMENTS AND PROCESS.

All those interested in taking part in the participation process, regardless of their status as members of the CLUB, must fulfil the requirements given below:

- a) Subscribe to the "Barça Fans" newsletter and participate in the terms and conditions set forth herein.
- b) Have an email address which is "registered" in FC BARCELONA's "Barça Fans" newsletter.
- c) Each participant in the draw can take part once (1) and will therefore only register once (1). Any duplication will be monitored by a computer security system to ensure that only one (1) registration is admitted per participant, all additional registrations by the same person shall be terminated.
- d) One (1) single file will be created from a correct "registration of participation" as has been stated in this condition, regardless of the language used.

## CONDITION 5. DRAW PROCESS.

- a) In the event there is no participant, it will not be necessary to hold the draw which will automatically be declared deserted.
- b) In the event that only one (1) participant takes part in the activity, the draw shall not be held as he/she shall automatically be the winner. Therefore, this person shall be awarded the prize directly, without the draw being necessary. hours) starting from the moment the first notification occurs, for any reason or circumstance beyond the CLUB, the winner shall lose his/her rights to the prize, it being awarded to the first reserve and so on successively.

j) The participant who wins the prize must accept it, or in the case of minors, their parents or legal representatives of legal age who hold or are assigned their legal guardianship must expressly declare their acceptance or rejection. In the first case, the instructions provided by FC BARCELONA regarding the logistics of delivery and, if applicable, collection of the prize, must be followed strictly.

## CONDITION 6. PRIZE.

The winning participant whether by direct allocation or the draw, shall obtain the prize indicated below:

In the event that the winner is a minor (under 18 years of age), he/she must attend the game that is the subject of the prize accompanied by one (1) adult, who may be any of his/her parents or the person of legal age assigned as his/her legal guardian.

In no case does the prize includes any other concept other than that described above, either for the winner or, if applicable, for their companion.

## CONDITION 7. ACCEPTANCE OF THE PRIZE.

# FC BARCELONA

- a) Entrance to the Palau Blaugrana shall be subject to compliance with:
- The regulations of the Palau Blaugrana in Barcelona.
  - The stipulations of any applicable regulations regarding access, security, safety, etc.
  - Actions that, for reasons of security, may relate to entrance to the Palau Blaugrana, such as inspections, searches, etc.
- b) The two (2) tickets that make up the prize that is the purpose of these regulations are personal and non-transferable. They must therefore necessarily be used by the winner and companion that the winner assigns at his/her sole and exclusive criteria, and each of these shall be responsible for the good use of the same. Consequently, sale of the tickets and/or any other kind of onerous transfer and transmission of the same is strictly forbidden, as is their use for advertising, marketing or promotional purposes (including competitions, gifts and/or draws), which could lead to automatic cancelation of the same with no right to compensation and/or reimbursement of the cost.

If anything untoward is detected, such as the lack of correspondence between the identity of the winner (and/or their companion) and the bearers of the tickets, entrance by the aid persons to the Palau Blaugrana shall be refused, and the tickets shall be handed over to FC BARCELONA, or the competent authorities in that respect (e.g. private security, security forces), and shall be automatically cancelled, with no right to compensation and/or reimbursement of the cost.
- d) The winner and their companion must keep hold of the ticket not only during the match but also as long as they remain on the Palau Blaugrana premises, and must show these tickets to any staff designated by FC BARCELONA, the RFEF or the competent authorities in this respect should any of these so request.

- f) Notwithstanding the consequences established for each of the aforesaid irregularities, any of these offences shall also be reported to the FC Barcelona Disciplinary Board in order for it to adopt any corresponding measures, and to any corresponding authorities, in order for these to adopt any corresponding administrative, police and/or legal measures.

## CONDITION 10. DEPOSITING THE CONDITIONS BEFORE A NOTARY PUBLIC.
