



Official Terms and Conditions for the Meet and Greet Lewis Hamilton Competition – MERCEDES AMG PETRONAS Formula One Team (“Prize Draw”)

The Promoter is Mercedes-Benz Grand Prix Ltd (“Promoter”), Operations Centre, Brackley, Northamptonshire NN13 7BD, England.

By entering this Prize Draw entrants will be deemed to have accepted these terms and conditions (“Prize Draw Terms and Conditions”) and agreed to be bound by them when entering this Prize Draw.

There is no purchase or payment necessary to enter or win this Prize Draw.

This Prize Draw is in no way endorsed by Facebook or any other social media channel.

1. Prize Draw Eligibility and Entry Criteria

- 1.1 This Prize Draw is open to all persons aged 18 years and over who have a valid driving licence and is entering from one of the jurisdictions permitted by the Promoter (at its sole and unfettered discretion). The entrant shall warrant that their entry shall not breach or render the Promoter in breach of any applicable law in the country in which the entrant normally resides and/or has entered from and shall warrant that the guest of the winner has read and agrees to be bound by these Prize Draw Terms and Conditions.
- 1.2 The Promoter reserves the right to ask for proof of age and verify the identity of an entrant and their guest. Accordingly, entrants shall provide such reasonable documentary evidence as the Promoter shall specify in order to verify the age and identity of the relevant entrant and their guest.

2. How to Enter the Prize Draw

3. Winner Selection

- 3.1 Following expiry of the Promotion Period, ten (10) winners shall be selected at random from all valid and eligible entries. Each winner will win a Prize.
- 3.2 Winners will be notified by email using the contact details submitted on or before 17:00 UTC on 2 December 2016. Please ensure that you check your spam/bulk/junk folders and ensure the relevant account remains active in order to avoid missing the notification as the Promoter shall not be liable in the event that any notification is not received by a winning Entrant in such circumstances.
- 3.3 Subject to 3.4, winners will have 48 hours to respond from the date upon which they are notified by the Promoter that they have won the Prize Draw to claim their Prize.
- 3.4 If any winner does not or is not able, for any reason, to claim or accept a Prize (by the relevant deadlines set out at 3.3), or cannot be contacted within 48 hours of the draw date, the Promoter reserves the right to award the prize to another Entrant and the previous winning Entrant waives all claims against the Promoter in respect of the Prize Draw.

4. Prize

- 4.1 Each winner shall win the following:

The chance for the winner and one guest (who must also satisfy the eligibility criteria set out in clause 1) to attend Mercedes-Benz World, Brooklands Drive, Weybridge, Surrey, KT13 0SL ("MB World") on 9 December 2016 (the time which will be communicated to the winner). The winner and the guest will have the chance to:

- Ride on the MB World Handling Circuit, with Lewis Hamilton; and
- Meet and greet Lewis Hamilton at MB World.

(together the "**Prize**").

- 4.2 The Prize does not include accommodation, travel to or from MB World, personal expenditure or other incidental costs other than those specifically included in clause 4.1. Prior to attending MB World, the winner and their guest will be required to sign additional documentation supplied by the Promoter which shall include but shall not be limited to a confidentiality agreement and a driving experience waiver.
- 4.3 The Promoter reserves the right to substitute the Prize (or any part of them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control.
- 4.4 There is no cash alternative to the Prize (or any part of them) and unless agreed otherwise in writing the prizes are non-refundable, non-transferable and cannot be sold or given away by the winners.
- 4.5 Third party terms and conditions apply to parts of the Prize where applicable, including the terms of entry to MB World.

- 5.1 So far as is permitted by law and subject to clause 5.3, the Promoter and its associated companies and agents exclude responsibility and all liabilities arising from:
 - (i) any postponement or cancellation of the Prize Draw;

- (ii) any changes to, supply of (including, without limitation, prizes which do not reach the intended recipient), or use of the prize;
 - (iii) entries that are submitted from jurisdictions in which this Prize Draw is rendered unlawful; and
 - (iv) any act or default of any third party supplier, which are beyond the Promoter's reasonable control.
