

## **Terms and Conditions**

### **“TISSOT WATCH GIVEAWAY – FWBWC 2022” (the “Draw”)**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** The Draw is open only to those who sign up at the dedicated Draw digital form and who are at least 18+ years old at the time of entry. The Draw is open to the legal residents of all countries, except this offer is void where prohibited by law. Employees of FIBA their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Draw.
