

## TERMS AND CONDITIONS

### Win an unforgettable trip to Manchester Prize Draw

#### Entry

1. Manchester United Football Club Limited ("**MU**") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA (the "**Stadium**")) is the promoter of the Win an unforgettable trip to Manchester prize draw (the "**Prize Draw**").
2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
3. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.

The Prize Draw is open to entrants aged 18 years or over at the date of entry.

4. Entry into the Prize Draw is free (except for any applicable data usage charges) and on the basis of one entry per person.
5. In order to enter the Prize Draw and to be considered for the Prize, entrants must complete the relevant data entry fields for the Prize Draw:
  - i. through the competition form available at [www.Manchesterunited.com/melitta-fan-competition](http://www.Manchesterunited.com/melitta-fan-competition); or
  - ii. via any other method of entry which MU makes available.
6. The Prize Draw will close at 23:59 GMT on Friday, 1<sup>st</sup> March 2019 (the "**Closing Date**") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.

#### Prize

7. The prize will consist of the following for each Winner and their guest, and will take place during the weekend of the Premier League game between Manchester United and Watford FC (expected dates are 30<sup>th</sup>/31<sup>st</sup> March 2019 however final dates will be confirmed by Manchester United – travel dates may therefore vary accordingly):
  - a) Return transportation (standard class) to Manchester, including economy class flights to Manchester for Winners located outside of the UK (to be agreed by MU and the Winner) (in the event the parties cannot agree, MU will make a decision);
  - b) Transportation (standard class) to and from the Stadium and to and from the Manchester United training session (to be agreed by MU and the Winner) (in the event the parties cannot agree, MU will make a decision);
  - c) The opportunity to watch a Manchester United training session;
  - d) A stadium tour of Old Trafford;
  - e) Tickets (one for the Winner and one for their guest) to a Manchester United home game to be held in the Stadium, including meals before and after the match;

- f) A hotel in Manchester city centre for 2 nights for the Winner and their guest (based on two adults sharing a double or twin room on a room only basis);
  - g) Lunch at the Red Café supported by Melitta, including a 'meet and greet' with a former Manchester United player (identity of the former player will be at MU's choice); and
  - h) All other meals during the Winner's trip to Manchester.
8. The Match Ticket Terms and Conditions (available on request from Ticketing & Membership Services and at [www.manutd.com/termsandconditions](http://www.manutd.com/termsandconditions)) apply to the use of facilities at the Stadium.
  9. MU reserves the right to substitute the Prize with another of a similar nature at any time. Any ancillary costs and expenses associated with the Prize, such as subsistence, will not be provided by MU and must be borne by the Winner.
  10. The value of the prize will vary subject to the location of the Winner and travel costs at the time of booking. For Winners from China, USA/Canada and Brazil the value of the prize is estimated to be c.4.200 Euros (net) per Winner. For Winners from Germany, UK, Austria, Switzerland, Belgium/Netherlands, Sweden/Denmark and France the value of the prize is estimated to be c.2.200 Euros (net) per Winner.
  11. The Prize is non-transferable and there is no cash alternative.

#### **Winner**

12. One winner will be selected from each of the following regions: USA/Canada, Brazil, China, Germany, Switzerland, Austria, France, Belgium/Netherlands, England and Sweden/Denmark (10 winners in total). The winner will be the first person selected at random from all valid entries from each region received on or before the Closing Date in each of the above countries (the "**Winner**"). Each Winner will receive the Prize.
13. Only the Winner will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, MU will be in contact about the Prize.
14. The Winner will be required to give their consent to the following: (i) for the Winner's name to be disclosed to any person requesting that MU confirms the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional purposes, although the Winner may raise any concerns regarding this paragraph 14 with MU.
15. If MU cannot successfully contact the Winner within a reasonable length of time, or if the Winner is unable or unwilling to accept the Prize, or if the Winner does not meet the eligibility requirements, or if the Winner does not provide the consent requested at paragraph 14 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be the Winner for the purposes of these Conditions.
16. Subject to paragraphs 14 and 15 above, details of the Winner will be made available to the public upon request from Manchester United Football Club Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

#### **General**

17. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.
18. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
