

## TERMS AND CONDITIONS

### NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.

1. These terms and conditions (“**the Rules**”) govern the „**MOTOGP™ - 2020 SUPERPOLE CONTEST** “ (“**the Contest**”) administered by Tissot Ltd, domiciled at Chemin des Tourelles 17, 2400 Le Locle, Switzerland („**Tissot**“, “**us**”, “**our**”, “**we**”).
2. By participating in this Contest you agree to these Rules and to abide by it. You confirm to have read and understood our Privacy Notice. Our Privacy Notice is available at <https://www.tissotwatches.com/en-en/shop/privacy-policy> .
3. The Contest is in no way sponsored, endorsed, or administered by Facebook, Twitter or Instagram. All information disclosed is provided to us and not to Facebook, Twitter or Instagram. You hereby release Facebook, Twitter and Instagram, to the greatest extent legally permissible, from any liability in connection with the Contest.
4. Entry is open to anyone aged 18 or over at the start of the Contest, with the exception of our employees (and their families) as well as of our affiliates, of agents and of anyone else involved in the Contest.
5. Several MotoGP qualifying races will take place between the 8th March 2020 and 8th November 2020, more precisely on the following dates: 8th March 2020, 19th July 2020, 26th July 2020, 9th August 2020, 16th August 2020, 23rd August 2020, 13th September 2020, 20th September 2020, 27th September 2020, 11th October 2020, 18th October 2020, 25th October 2020 and 8th November 2020. There is one contest per MotoGP weekend and each contest begins 48 hours before the first qualifying race and ends 1 hour before it.
6. Each participant may participate only once to each contest related to a specific MotoGP qualifying race but to every single contest related to a specific MotoGP qualifying race.

To participate, please go on the following link: <https://www.tissotwatches.com/en-en/shop/motogp-2020.html?test6> and follow the steps indicated i.e. guess and enter the pole position winner’s race time including minutes, seconds and hundredths in the boxes provided for this purpose and filled out the required data. This link is also accessible through publications on Tissot Social Media pages.
8. Even if you follow these rules and instructions correctly, the possibility of events or conditions beyond our control means that we cannot guarantee your successful participation.
9. The provision of any invalid, incorrect, or misleading personal information may, in our sole discretion, lead to disqualification from the Contest and/or receipt of a prize.
10. Incomplete, late, or otherwise faulty entries are not accepted.
11. The winners will be made up each Monday following each MotoGP qualifying race according to the following rules:
  - If only one participant has guessed the correct timing, this participant is the winner.
  - If several participants have guessed the correct timing, the winner is drawn by random among them.

- If no participant has guessed the correct timing, the winner is the one with the result closest to the correct timing.
- 12. Each winner receives the following prize: a Tissot T-Race MotoGP watch (reference T115.417.27.051.01) with a recommended retail price in Switzerland of CHF 745.00. The watch pouch is signed by the MotoGP rider taking the Pole position during the qualifying session
- 13. The winners will be notified via email within 7 days after the selection.
- 14. If a winner cannot be reached or does not reply within 5 days of the prize notification, the prize will be assumed to have been forfeited and will be awarded to another contestant.
- 15. We reserve the right to select an alternative winner if we reasonably believe that a winner has breached the Rules.

In the event of a dispute as to a person's identity, the entry will be deemed to have been made by the holder of the email address associated with it.
