## **TERMS ANDS CONDITIONS OF THE Barcelona Obertura "WIN TRIP" CONTEST**

Fundació Orfeó Català - Palau de la Música Catalana/Barcelona Obertura (hereinafter Barcelona Obertura), with registered office for the purposes of this promotion at Carrer Palau de la Música 4-6, and with C.I.F. number G59684548, organises the contest “**WIN TRIP**”, hereinafter “the promotion” for the promotion of its products and web content, in accordance with the following terms and conditions:

### **1. Scope of application**

#### **1.1. Period of validity**

The promotion begins on 17 April 2023 and ends on 16 July 2023.

#### **1.2. Attendance**

The prize is open to all individuals over 18 years of age, resident outside Spain, who comply with these terms and conditions. Each participant is entitled to a only one entry to the promotion.

#### **1.3 Territory**

The territorial scope of the promotion is Europe.

### **2. Acceptance of the terms and conditions**

Participation in the promotion implies the acceptance of the terms and conditions by the participants in the promotion, as well as acceptance of the criteria of Barcelona Obertura regarding the resolution of any question related to the Terms and Conditions of the promotion.

### **3. Procedure for the Promotion**

#### **3.1 Participation will be exclusively through the web page:**

To participate, it is necessary to:

1. Complete the form answering any and all questions and indicating name, surname, e-mail address, country and contact telephone number.
2. Read and accept the legal conditions.
3. Click on the "Send" button

**3.2 Barcelona Obertura** reserves the right to declare void those entries in which fraudulent use is detected or reasonably suspected. Participants in such cases will lose all rights to any of the prizes for entries deemed to be fraud or deception. By way of example but not limitation, the use of robots, etc. will be understood as abuse or fraud. If the same individual submits the same form more than once, only one entry (the last one) will be entered into the competition and considered valid.

### **4. Prizes**

4.1 The following prizes will be awarded through this promotion:

1 trip of 3 days (2 nights) to Barcelona (Spain) for 2 persons, including:

- Return flight to Barcelona Airport.
- Two nights' accommodation at the Hotel Grand Hotel Central (5\*), in a double room, breakfast included.
- Concert at the Gran Teatre del Liceu, Palau de la Música or Auditori.
- Lunch or dinner in front of the sea. The lunch or dinner will have a closed menu and will consist of starter, Paella, dessert, wine or sangria, water and coffees.

Prize valued at: 3.000€ (Three thousand Euros).

This valuation is for guidance only and does not represent any real or implied contract. No cash or other alternative will be offered in Lieu of the prize offered.

*\*The prize will be valid from 15 September to 15 November 2023.*

4.2 Barcelona Obertura reserve the right to ask the winners to identify themselves by showing their ID card or passport. Refusal to provide such documentation or in the case that documentation does not match the data provided upon entering the competition and subsequent administration of the prize will result in the loss of the right to receive the prize.

#### **4.3.-DRAW.**

The winner of the trip to Barcelona will be chosen on 18 July 2023, and Barcelona Obertura reserves the right to modify this date at its convenience.

Barcelona Obertura will provide the Notary with the database containing all the participants in this promotion. The notary will randomly draw 1 winner for the trip to Barcelona and 2 successive participants to act as substitutes if it is not possible to identify or locate the winner.

### **5. Communication and awarding of prizes**

#### **5.1 Communication**

The winner will be notified by Barcelona Obertura via the e-mail address provided by the winner in their entry within a period of no more than 8 calendar days from the date on which the promotion ends.

It shall be understood that Barcelona Obertura has taken all necessary steps to locate the winner of the prize if after 5 (five) calendar days after the prize winner has been contacted via the provided e-mail address, the winner has not replied. This will result in the awarding of the prize to this winner being declared null and void.

Once acceptance of the prize has been confirmed, Barcelona Obertura will publish the name of the winner on its Instagram page.

### **6. Protection of personal data.**

The personal data voluntarily provided by the participant must be truthful and complete. If not, Barcelona Obertura will be entitled to exclude the participant in question from the promotion.

It is understood and accepted that any personal data submitted in relation to the promotion may be kept by Barcelona Obertura in their files in order to manage the

present promotion, as well as to inform participants of new promotions, offers, products and services of the said company and to carry out opinion surveys, both by analogic and electronic means (telephone, e-mail, SMS, etc.) if you have given your consent for the same. The provision of consent to the processing of personal data for the management of the promotion is mandatory, for commercial actions consent is optional.

Additional personal data provided by the winners for the reception and, if applicable, public communication of the prize, will be used exclusively to carry out the correct management of said public communication and delivery of the prize.

Personal data provided may be shared, if necessary due to the transfer or merger of assets, between the different classical music theatres that form part of Barcelona Obertura. All the classical music theatres that form part of Barcelona Obertura comply with legislation regarding the protection of the personal data of their subscribers and registered users and all data is handled in the strictest confidence in accordance with the provisions of Organic Law 15/99 of 13 December 1999 on the Protection of Personal Data and other implementing regulations.

The requirement for winners to provide their data is compulsory only insofar as being necessary for the management of the prize.

## **7. Acceptance of the prizes**

Once the winners have been contacted, they will be sent an e-mail of acceptance of the prize, so that they can proceed to the payment on account established by Royal Decree 439/2007, of 30 March.

The e-mail of acceptance must be completed in full by the winner, attaching a copy of his/her ID card and sent within a maximum of 15 calendar days from receipt of the e-mail by the winner.

The Organisation will consider that the prize has NOT been accepted and has been renounced if:

- The return to the Organisation of the acceptance e-mail without including the winner's express and unconditional acceptance of the Prize. Conditional or limited acceptances are not valid. OR-
- Non-receipt of the acceptance e-mail within the stipulated period (15 calendar days). OR-
- If, at the time of sending the corresponding prize to the winner, it is found that the address or e-mail address provided at the time of registration or at the time when this information is requested when notifying the winner, is false or does not correspond to the winner's address or e-mail address. OR-
