

TERMS AND CONDITIONS

NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING.

Thank you for your interest in our "2025 Golden Ticket Giveaway" promotion (the "**Prize Draw**"). These are the terms and conditions (the "**Terms and Conditions**") for the Prize Draw. Entry/claim instructions form part of the Terms and Conditions and by entering this Prize Draw, each entrant will be deemed to have accepted and agree to be bound by these Terms and Conditions, so please read the following carefully.

- b. The winner may select one other person to take with them as their guest.
